

Information about the processing of personal data

Information about the processing of data subject's personal data under Paragraph 19 and Paragraph 20 of the Act No. 18/2018 Coll. on Personal Data Protection and on the amendment of certain other Acts (hereinafter referred to as the "Act") and Article 13 and 14 of the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as the "Regulation")

This information aims to provide knowledge about what personal data we process, how we deal with it, for which purposes we use it, to whom we can provide it, where you can obtain information about your personal data and enforce your rights in the processing of personal data.

1. The purpose of personal data processing and legal basis for processing

The purpose of the personal data processing is: providing and improving services, developing new services, users protection and providing effective search and advertising

Personal data are processed on the basis of: voluntary consent of data subject pursuant to Paragraph 13 point 1 (a) of the Act and Article 6 point 1 (a) of the Regulation, Directive 2002/58/EC of the European Parliament and of the Council

The legitimate interest of the Controller or third party

The processing of personal data for a purpose of the legitimate interests of the Controller or third party does not apply.

2. Identification of the processed personal data of the data subject

Data subjects, whose personal data are processed are: users and visitors of the Controller's website.

The extent of processed personal data: title, name, surname, nickname, e-mail, telephone number, IP address and the way, (website), where the client comes from, GPS localization, photograph.

Identification of recipients, categories of recipients

The Controller may provide personal data to authorized entities, such as institutions and organizations, under specific legal regulation or to the contractors (especially the data Processors) who have undertaken to accept reasonable safeguards for the protection of the processed personal data, as follows:

Personal data may be provided to other recipients if the data subject consents or orders to provide his/ her personal data to them.

3. **Transfer of personal data to third country/ international organization**

Transfer of personal data to third countries or international organizations does not apply.

4. **Identification of the source of which the data were collected**

Directly from the data subject (by using Controller's website).

5. **The retention period of personal data**

The Controller shall process personal data for the time necessary to fulfill the purpose.

6. **Profiling**

The Controller does not process the personal data by profiling, or by other similar means based on automated individual decision-making.

7. **Rights of the data subject**

The data subject shall have the right to request from the Controller the access to processed personal data concerning him/her, the right to rectification of personal data, the right to personal data erasure or restriction, the right to object to the processing of personal data, the right not to be subject to a decision based solely on automated processing, including profiling, the right to data portability as well as the right to initiate the proceeding to supervisory authority. When the Controller processes the personal data based on data subject's consent, the data subject shall have the right to withdraw his or her consent to processing at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. The data subject can exercise his/her rights by sending an e-mail to e-mail address: uniquepeople@uniquepeople.net or by sending the letter to the address of the Controller.

8. **Obligation to provide personal data**

Data subject provides his/ her personal data on the voluntary basis, based on the consent (the provision of personal data is not a legal requirement/ contractual requirement), in case that data subject refuses to provide personal data, the Controller will not monitor and evaluate the behavior of the website user for the purpose of provision, improvement and development of new services, user protection, and providing effective search and advertising.
